# **Regional Conference**

### **Member Link**

My support team and I have begun to contact u3as. I have to say that it is a very enjoyable experience to speak to enthusiastic Chairs about what they are doing. So many of you have been working incredibly hard through this difficult time to keep your members involved and engaged. Ideas are being shared at Network meetings and support offered for any u3a committees that are struggling.

I do not think that life will ever return to being exactly how it was before Covid 19 hit us a year ago. We need to consider how our organisation could adapt, so as to encourage younger members and to manage groups and meetings in inclusive ways.

#### Slow Ways project

The aim of this is to use footpaths to create routes between communities. Last year thousands of routes were recorded and it is hoped that they will be tested out as soon as possible. The Third Age Trust is in discussions about working with the project but, in the meantime there is nothing to stop anyone signing up to the project to be kept informed and to get involved. ### Membership renewal and annual subscriptions

Many u3as have made the decision to reduce their membership subscriptions this year, and to use their reserves to keep going. As you know, the annual subscription to TAT will be based on your membership on March 31st this year so, even if you have agreed to no charge it is well worth you going through a renewal process, so that you have an accurate figure. If your renewal date is 1<sup>st</sup> April and you expect your membership to fall at that time, do contact the Trust, so that a fair amount can be agreed. #### Finance Advice

Richard Teare, the national Treasurer, is offering virtual 'Question and Answer 'sessions. He has just held one in the north east that proved very popular. I think this is something that would be worth providing on a regional basis, and will let you know when I have a date.

### **AGMs & Constitution**

I know that many u3as are changing their Constitution to allow for future virtual or hybrid AGMs. There is now a new model Constitution available on the website, which includes the relevant clauses.

# **Public Liability Insurance**

Some eagle eyed committee members have spotted that one of the excesses in the new policy has increased to £5000, and were understandably concerned. In fact, there is nothing to worry about. Here is the information from Tony Carlisle, who deals with insurance matters for the Trust.

"Under the Management Liability policy the excess has changed from £1,000 to £5,000 for 2021 BUT only for the Corporate Legal Liability section of the policy. The section of the policy which affords cover for individuals is unaltered from 2020 and does not have an excess at all. The insurance market for Management Liability policies is in complete turmoil at the moment as management for many organisations, charities and businesses, struggle to deal with the implications of Covid 19. The decision by Aviva to increase the Corporate Legal Liability excess applies to all of their customers and is not U3A specific and is in line with general market trend. The vast majority of U3A's as unincorporated associations are completely unaffected by this change."
